Hello CHASE members and Happy New Year! We're approaching our second year since we began writing the Chase Report newsletter.

### Form 300A Logs Due

We have a lot of announcements this quarter and I'd like to begin by reminding everyone that Form 300A logs are due to be posted February 1, 2023. Each year, from February 1 through April 30, employers must post a summary of the injury and illness log from the previous year (OSHA Form 300A) in a place where workers can see it. Workers and their representatives have the right to receive copies of the full OSHA form 300 log. Following a request, employers must make copies available at the end of the next business day.

### Governor's Safety and Health Conference

The 41<sup>st</sup> Annual Alaska Governor's Safety and Health Conference (GSHC) will be held April 4-5, 2023, at the William A. Egan Civic and Convention Center in Anchorage. This year's theme is "The Gold Standard in Safety and Health." The conference cost is \$225 per person and \$200 if you register by February 28.
